

Station to Station: Personalizing Learning for the Secondary ELA Classroom *Half Day*

Participants will learn by doing in this hands-on training. The focus will be on how to use the Station Rotation Model of Blended Learning to differentiate literacy instruction across the strands of Reading, Writing, Speaking, and Listening. The process starts with data and ends with student engagement in standards-based tasks that are designed for their strengths and needs.

Teacher-led Whole Group

- Kicks off the lesson
- Direct, explicit instruction of reading strategies.
- Models the strategies.
- Models what the expectations for each station.

Teacher-led Small Group Intervention

- Based on ability of skill
- Intensive intervention and extension
- Use of Text-Dependent Questions through Guided, Close Reading



Online Differentiated Instruction

- Monitored by the teacher
- At the instructional level of the student
- Levels increase as students grow

Small Group Collaborative Learning

- Strategic, flexible grouping
- Multiple modalities
- Authentic tasks
- Student accountability
- Feedback for learning
